Dear Mr. Mahony:

On Saturday, July 9, 2016 the Italy American Club located next door to my house had a function where alcohol was served. In the mid to late afternoon, my son, who was visiting my house with his wife and children, was sitting outside on the steps talking to one of his friends. While he was outside with his friend he noticed a woman come staggering out of the ITAM Club parking lot and start talking to a bush on the property line between my house and the ITAM. She then proceeded to pull down her pants and urinate. When she was finished, she pulled up her pants, pulled herself up using the bush and walked (staggered) back into the ITAM Club parking lot. My son could not see where she went from there because we have a fence separating the property.

I called the Marlboro Police Department and two officers did come down to check into this matter. They could not find the woman but they did talk to the club concerning this matter. However, I feel stricter measures should be taken with the ITAM Club concerning this and other matters. It is my understanding that the ITAM Club has a capacity of 120 people. It is quite clear to me that there were well over that amount at the club on July 9<sup>th</sup>. The parking lot of the ITAM Club was full. There were cars parked up and down Neil Street and Zompetti Street on both sides of the road and there appeared to be some cars parked in the Department of Public Works parking lot.

These cars were an inconvenience for the people living in the neighborhood. If we wanted to have a private party at our own home we couldn't, there was no place to park. Also, across the street from me is a property owned by National Grid. A couple of their trucks came down the road and had trouble maneuvering due to all the cars. I can only wonder if a fire truck would have been able to get through. I don't understand why the ITAM Club was not required to hire a police officer to prevent any of these issues from occurring.

My husband and I have had other smaller issues with the club that have bothered us, but in the spirit of being good neighbors we have not said anything. However, after this latest incident, I feel that something should be said. One of these issues is beer bottles being thrown over the fence into our yard. Another problem is that when people leave the club they tend to gather in the parking lot and talk quite loudly. I am usually sleeping when the club closes, and these little gatherings wake me up. It appears that the ITAM Club is unable to control the people they have in their club drinking.

In conclusion, I feel that the ITAM Club needs more supervision when they have functions. People should not be getting so drunk that they publicly urinate, the facility should not be overcrowded, cars should not be parking on both sides of the street and the neighbors should be respected.
