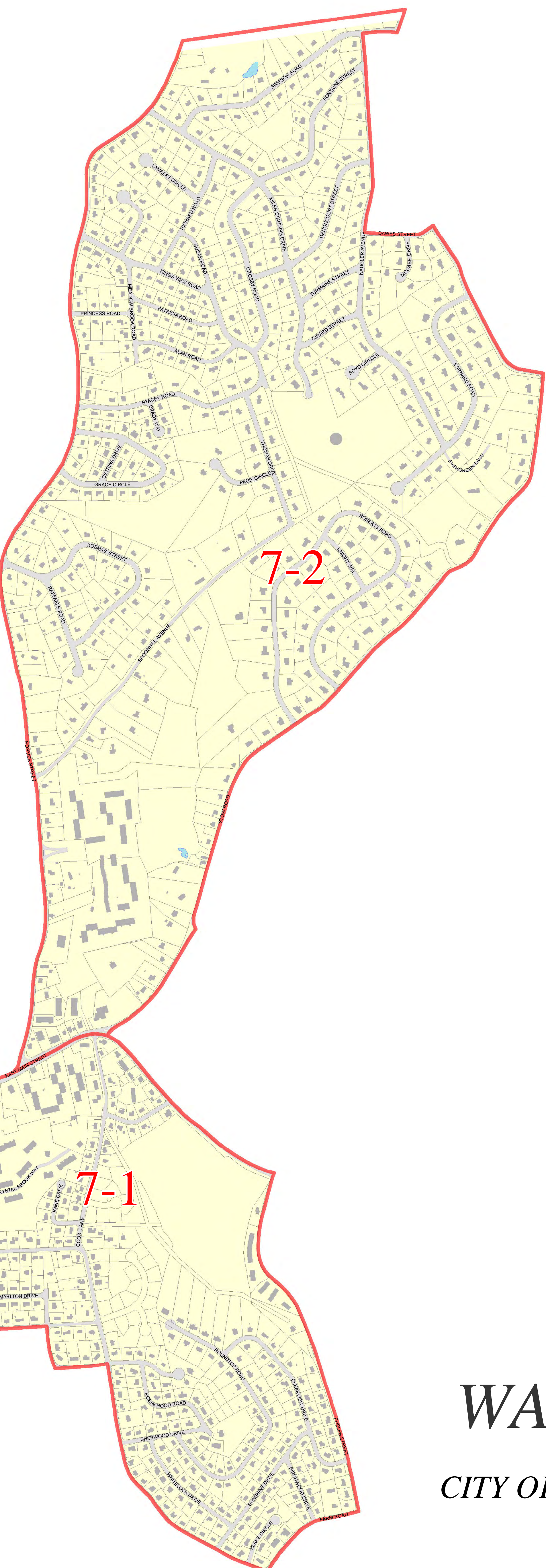


Ward Locations in Marlborough

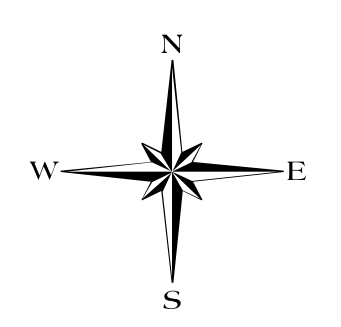
