

TRADESPERSON INSTALLATION, REPAIR & MAINTENANCE SERVICES

All procurement procedures shall conform to M.G.L. c. 30B, c.30, § 39M, c.149, §§44A-J, as applicable and subject to minimum prevailing wage rates as required by M.G.L. c.149 §§26-27H inclusive, as applicable. The services will be provided on an as needed basis and are estimated to cost less than \$50,000 per job/project. The maximum contract term shall be five one-year terms with no renewal options. In instances where CONTRACT NO. PF 2019-TRD for Categories 1-28 is used for services in excess of \$25,000, MGL c. 149 s. 29 requires that the Contractor submit a payment bond in the amount of 50% of the estimated contract value for c. 149 Public Building Construction or for c. 30, s. 39M Public Works projects under \$50,000.
