

LEGAL NOTICE NOTICE TO BIDDERS

The City of Marlborough (“City”), the Awarding Authority, invites sealed bids from contractors for the **Replacement of Lead Services Phase IV at Various Locations & Appurtenant Work in Marlborough, Massachusetts, CONTRACT NO. ED 2021-04** for the Department of Public Works- Engineering Division in accordance with the documents prepared by Tata & Howard, Inc. The project consists of a base bid with the replacement of approximately 227 suspected lead service connections at various locations throughout the City, including all labor, material and equipment necessary to complete the Work. The project also consists of an Additive Alternate A with the replacement of approximately 255 suspected lead service connections at various locations throughout the City, including all labor, material and equipment necessary to complete the Work. A portion of the Additive Alternate A suspected lead service connections are within the MassDOT Right-of-way. The estimated project cost is approximately \$2,600,000.00. Bids are subject to M.G.L., c. 30, §39M, and to minimum wage rates as required by M.G.L. c.149, §26 through 27H inclusive. Bid documents are available as of **9:00 AM on Thursday, May 13, 2021**. Each bid must be accompanied by a bid deposit in the amount of 5% of the total contract price including any alternates.
