The City of Marlborough ("City"), the Awarding Authority, invites sealed bids from contractors for the **Resurfacing and Reconstruction of Various Streets & Appurtenant Work in Marlborough, Massachusetts, CONTRACT NO. ED 2021-05** for the Department of Public Works-Engineering Division in accordance with the documents prepared by the City of Marlborough. The project consists of, but not limited to pavement micro-milling, full-depth reconstruction, replacement of HMA berm/sidewalks, curb r&r, construction of wheelchair ramps, driveway blending, loam/seeding and roadway paving throughout the City, including all labor, material and equipment necessary to complete the Work. The estimated project cost is approximately **\$2,500,000.00**. Bids are subject to M.G.L., c. 30, §39M, and to minimum wage rates as required by M.G.L c.149, §26 through 27H inclusive.
