

NOTICE TO BIDDERS

The City of Marlborough (“City”), the Awarding Authority, invites sealed bids from contractors for the **Sudbury Street Area Sewer Project & Appurtenant Work in Marlborough, Massachusetts, CONTRACT NO. ED 2021-06** for the Department of Public Works-Engineering Division in accordance with the documents prepared by the City of Marlborough. The project consists of installing new gravity sewers, new sewer service connections, installation of water mains and service connections, replacement of water services, temporary and permanent paving, including all labor, material and equipment necessary to complete the Work. **The estimated project cost is approximately \$1,175,000.00.** Bids are subject to M.G.L., c. 30, §39M, and to minimum wage rates as required by M.G.L c.149, §26 through 27H inclusive. **Bid documents are available as of 9:00 AM on Wednesday, July 14, 2021.** The project documents must be obtained by following these instructions: Go to www.Projectdog.com and click “Sign Up” for free, or login with your existing account. Each bid must be accompanied by a bid deposit in the amount of 5% of the total contract price.
