The City of Marlborough ("City"), the Awarding Authority, invites sealed bids from contractors for the **Marlborough Standby Water Pump Station in Marlborough, Massachusetts, CONTRACT NO. ED 2021-07** for the Department of Public Works-Engineering Division in accordance with the documents prepared by the City of Marlborough and Weston & Sampson Engineers, Inc. The project will include the construction of a multi-pump, submersible, pitless pumping system, a new separate electric service, and all related piping and control services, including all labor, material and equipment necessary to complete the Work. The estimated project cost is approximately **\$1,653,000.00**. Bids are subject to M.G.L., c. 30, §39M, and to minimum wage rates as required by M.G.L c.149, §26 through 27H inclusive. Bid documents are available as of **9:00 AM on Wednesday, January 27, 2021**. This project is being Electronically Bid (E-Bid). All bids shall be submitted online at www.Projectdog.com. Hard copy bids will not be accepted by Projectdog, Inc. or by the City of Marlborough. Tutorials and Instructions are available online at www.Projectdog.com. All bids are to be submitted to projectdog.com prior to **10:00 AM on Thursday, February 18, 2021**. Each bid must be accompanied by a bid deposit in the amount of 5% of the total contract price including any alternates. In accordance with the provisions of applicable statutes, laws, rules, regulations, and ordinances, the City of Marlborough does not discriminate in employment or the provision of services, and all qualified contractors will receive consideration without regard to race, age, color, religious creed, gender, handicap, sexual orientation, veteran's status or national origin.
