The City will not be responsible for the premature opening of proposals not properly identified, and such proposals will be rejected. LATE PROPOSALS WILL NOT BE ACCEPTED. After the proposal submission deadline, a register of proposals received will be made. Price Proposals shall remain confidential until such time as technical proposals have been evaluated.
