

NOTICE TO BIDDERS

The City of Marlborough (“City”), the Awarding Authority, invites sealed bids from contractors for the **Crack Sealing of Various Streets in Marlborough, Massachusetts, CONTRACT NO. ED 2021-11** for the Department of Public Works-Engineering Division in accordance with the documents prepared by the City of Marlborough. The project consists of all major items associated with crack sealing including but not limited to cleaning and sealing cracks throughout the City, including all labor, material and equipment necessary to complete the Work. The contract allowance amount is \$125,000.00. Bids are subject to M.G.L., c. 30, §39M, and to minimum wage rates as required by M.G.L. c.149, §26 through 27H inclusive. Bid documents are available as of **9:00 AM on Wednesday, July 14, 2021**.
