

## NOTICE TO BIDDERS

The City of Marlborough ("City"), the Awarding Authority, invites sealed bids from contractors for the **Resurfacing of Various Streets and Appurtenant Work in Marlborough, Massachusetts, CONTRACT NO. ED 2022-08** for the Department of Public Works-Engineering Division in accordance with the documents prepared by the City of Marlborough. The project consists of pavement milling, driveway blending, installation of cement concrete pedestrian ramps, loam/seeding and roadway paving/overlaying including all labor, material and equipment necessary to complete the Work. **The estimated project cost is approximately \$835,000.00.** Bids are subject to M.G.L., c. 30, §39M, and to minimum wage rates as required by M.G.L c.149, §26 through 27H inclusive. **The Bid Package may be obtained as of 9:00 AM on June 15, 2022** and must be downloaded from Projectdog.com by following these instructions: Go to [www.Projectdog.com](http://www.Projectdog.com) to log in or click "Sign Up" to create a new user account. Hard copies of bids will not be accepted by Projectdog.com or by the City offices. Each sealed electronic bid shall be submitted on the prescribed forms. Tutorials and Instructions are available online at [www.Projectdog.com](http://www.Projectdog.com). Bids will be available immediately for public view at the date and time stated above online at [www.Projectdog.com](http://www.Projectdog.com). Bids shall be clearly identified as per instructions at Projectdog's website. Bids shall be accompanied by a bid deposit of not less than five (5%) percent of the value of the bid in accordance with M.G.L. c. 30, §39 M (a), and made payable to the City of Marlborough, the Awarding Authority. The bid deposit may be submitted in the form of a certified check, a treasurer's or cashier's check issued by a responsible bank or trust company or a Bid Bond. In lieu of a Bid Bond, deposit checks must be submitted in a sealed envelope with a completed Bid Bond Affidavit form and received by the City before the bidding deadline. The Bidder must also submit a completed Bid Bond Affidavit form with their electronic bid. Bidders may download a blank Bid Bond Affidavit form at [www.Projectdog.com](http://www.Projectdog.com). Due to COVID-19 bidding protocols, at this time, the City is not accepting cash bid deposits. In accordance with the provisions of applicable statutes, laws, rules, regulations, and ordinances, the City of Marlborough does not discriminate in employment or the provision of services and all qualified contractors will receive consideration without regard to race, age, color, religious creed, gender, handicap, sexual orientation, veteran's status or national origin.
