

NOTICE TO BIDDERS

The City of Marlborough (“City”), the Awarding Authority, invites sealed bids from contractors for the Corrective Actions and Post-Closure Development of Hudson Street Landfill (Re-Bid), CONTRACT NO. ED 2023-17 for the Department of Public Works-Engineering Division in accordance with the documents prepared by Langdon Environmental, LLC. The work of this Contract includes furnishing all labor, materials, and equipment necessary for the construction of the proposed corrective actions including waste excavation and consolidation and construction of a new cap on a portion of the inactive Hudson Street Landfill Site and construction of a park facility as shown on the Drawings. The work also includes appurtenant and miscellaneous work, as specified, and as indicated on the Drawings. The estimated project cost is \$4,100,000.00. Bids are subject to M.G.L., c. 30, §39M, and to minimum wage rates as required by M.G.L. c.149, §26 through 27H inclusive. The Bid Package may be obtained as of 9:00 AM on August 3, 2023 and must be downloaded from Projectdog.com by following these instructions: Go to www.Projectdog.com to log in or click “Sign Up” to create a new user account. Enter Project Code 857271 in the search box and select “Acquire Documents” for a free, downloadable bid set. Hard copies of the documents may be purchased online. A free CD-ROM may be requested by contacting Projectdog – shipping & handling charges apply. Neither Owner nor Designer shall be responsible for full or partial sets of Bidding Documents, including Addenda if any, obtained from sources other than Projectdog Inc. Questions concerning the bid specifications must be submitting in writing via email to Attn: Bruce Haskell at BHaskell@Langdonenv.com no later than seven calendar days prior to the scheduled bid opening. All questions and answers shall be distributed as an addendum to all on record as having received the bid documents. Electronic Sealed Bids will be received until 9:00 AM on August 18, 2023 through online submission at www.Projectdog.com. Hard copies of bids will not be accepted by Projectdog.com or by the City offices. Each sealed electronic bid shall be submitted on the prescribed forms. Tutorials and Instructions are available online at www.Projectdog.com. Bids will be available immediately for public view at the date and time stated above online at www.Projectdog.com. Bids shall be clearly identified as per instructions at Projectdog’s website. Bid Security shall be at least five percent (5%) of the greatest possible bid amount, considering all alternates. The Bid Security in the form of a Bid Bond shall be:

- a) with a surety company qualified to do business in the Commonwealth of Massachusetts and satisfactory to Owner;
- b) conditional upon the faithful performance by the principal of the agreements contained in the Bid; and
- c) submitted with your E-Bid online at www.Projectdog.com. In lieu of and ONLY IN LIEU OF an insurance Bid Bond certificate submitted as outlined above (items a. through c.), a Bid Security in the form of cash, or a certified check, treasurer’s, or cashier’s check issued by a responsible bank or trust company and made payable to the Owner must be submitted with a completed Cash Bid Bond Affidavit form and received by the Owner before the time of bidding. In addition, the Bidder must also submit a completed Cash Bid Bond Affidavit form with their E-Bid. Download the Cash Bid Bond Affidavit form at www.Projectdog.com.
