NOTICE TO BIDDERS

Pursuant to Chapter 30, Section 39M of the M.G.L., the City of Marlborough ("City"), as the Awarding Authority, through its Department of Public Works ("DPW"), Operations Division, invites sealed electronic bids (E-Bids) from qualified contractors to provide **TRAFFIC SIGNAL AND CONTROL DEVICE REPAIR AND MAINTENANCE SERVICES, Contract No. OP 2021-01** at various locations within Marlborough, MA. Response time to requests for services must be within four (4) hours of request by the City, unless other arrangements are made. The estimated cost for the work is \$50,000.00 per year. All bidding procedures shall conform to M.G.L. c.30, § 39M, and all bids are subject to minimum prevailing wage rates as required by M.G.L. c.149 §§26-27H inclusive.

The Bid Package may be obtained as of **10:00 AM on May 12, 2021** and must be downloaded from Projectdog.com by following these instructions: "Go to www.Projectdog.com and click "Sign Up" for free set, or login to your existing account. Enter **Project Code 843500** in the project locator box. Select "Acquire Documents" to download bid documents, including specifications and plans, review a hard copy at Projectdog's physical location at 18 Graf Road, Suite 8, Newburyport, MA 01950, or request a free project CD. DUE TO COVID-19 PROTOCOLS, UNTIL FURTHER NOTICE, PROJECTDOG HAS REVISED HOW ORDERS MAY BE RECEIVED. All questions and answers shall be distributed as an addendum to all on record as having received the bid documents.

Electronic Sealed Bids will be received **until 9:00 AM on May 26, 2021** through online submission at www.Projectdog.com. **Hard copies of bids will not be accepted by Projectdog.com or by the City offices. Tutorials and Instructions** are available online at www.Projectdog.com. **Bids will be available immediately for public view at the date and time stated above online at www.Projectdog.com. Bids shall be clearly identified as per instructions at Projectdog's website. Bids shall be accompanied by a bid deposit of not less than five (5%) percent of the value of the bid in accordance with M.G.L. c. 30, §39 M (a), and made payable to the City of Marlborough, the Awarding Authority.** The bid deposit may be submitted in the form of a certified check, a treasurer's or cashier's check issued by a responsible bank or trust company or a bid bond. Due to COVID-19 bidding protocols, at this time, the City is not accepting cash bid deposits. Each sealed electronic bid shall be submitted on the prescribed forms.

In accordance with the provisions of applicable statutes, laws, rules, regulations, and ordinances, the City of Marlborough does not discriminate in employment or the provision of services and all qualified contractors will receive consideration without regard to race, age, color, religious creed, gender, handicap, sexual orientation, veteran's status or national origin. The City reserves the right to cancel this procurement process, waive any informality in or reject in whole or in part any and all bids, if the City determines that cancellation or rejection serves the best interests of the public to do so. This legal notice shall also be posted by the local newspaper on the Massachusetts Newspaper Publishers Association's ("MNPA") website (masspublicnotices.org).
