## LEGAL ADVERTISEMENT REQUEST FOR QUALIFICATIONS DESIGNER SERVICES FOR HVAC UPGRADES - MARLBOROUGH PUBLIC SCHOOLS

Pursuant to M.G.L c. 7C, 44, the City of Marlborough as the Awarding Authority, through its Public Facilities Division ("City"), is requesting qualification statements from qualified "designers" for <a href="Pre-Design Services/Site">Pre-Design Services/Site</a> <a href="Analysis Phase to the Schematic Design Phase">Analysis Phase to the Schematic Design Phase</a> for heating, ventilation, and air conditioning (HVAC) upgrades for two locations including the Jaworek School located at 444 Hosmer Street and the Kane School located at 520 Farm Road in Marlborough Ma. Applicants must be qualified architects, engineers and /or other qualified responders licensed in the Commonwealth of Massachusetts and must be familiar with public construction laws. Previous experience in projects similar to the City's is required. Selection of a designer will be made by the Awarding Authority.

The City of Marlborough Public Facilities Department is seeking the services of a qualified designer to evaluate each building, provide schematic design, and perform comprehensive cost construction cost projections of appropriate systems for each location. In addition, if the City moves forward with the construction phase for either or both projects, the City may use the Designer selected for the design phase and/or preparation of bidding and construction documents by Contract amendment dependent upon City approval.

Request for Qualifications must be returned to the Procurement Office, City Hall, 140 Main Street, 3rd Floor, Marlborough, MA 01752 by June 30, 2021 at 2:00 PM. Sealed Qualification Applications shall be clearly marked "Designer Services For HVAC Upgrades-MPS- PF 2021-02". LATE QUALIFICATION STATEMENTS WILL NOT BE ACCEPTED. Applicants will be required to complete the Commonwealth of Massachusetts Standard Designer Application form for Municipalities and Public Agencies not within DSB Jurisdiction, as well as any supplemental requirements stated in the RFQ. The Designer Fee shall be negotiated. The City of Marlborough seeks to fund this project through federal grants made available by ESSER III. Contract award is subject to approval of grant funding and approval of the utilization of grant expenditures for this purpose and/or appropriation. Approved construction projects must comply with applicable Uniform Guidance requirements, as well as the Department of Education's regulations regarding construction at 34 CFR § 76.600. Any resulting construction contract must meet Davis-Bacon prevailing wage requirements.
