Lalo's Mexican Restaurant, 460 Lincoln St

Member Bouvier motioned to approve 28 seats for outside dining with the caveat that dumpsters were removed from the area and per the site plan submitted on June 17, 2020, to the Licensing Board. And that the plan meets all safety requirements and approval of the Building and Fire Department and is subject to and must comply with all ongoing and periodic on-site inspections to ensure continued compliance. Member Mitrakas seconded the motion; the Board roll call vote was unanimous at 3-0 in favor of the motion.

Brazilian Steak Grill - 416 Boston Post Rd E

Member Mitrakas motioned to approve eight seats for outside dining per the site plan submitted on June 17, 2020, to the Licensing Board. And that the plan meets all safety requirements and approval of the Building and Fire Department and is subject to and must comply with all ongoing and periodic on-site inspections to ensure continued compliance. Double T's, 11b Florence St., Additional Special Outside Seating

Member Mitrakas motioned to approve the four 6-Top Tables for 24 seats and additional seating across the street as approved by the Building Commissioner dining per site plan submitted on June 17, 2020, to the Licensing Board. And that the plan meets all safety requirements and approval of the Building and Fire Department and is subject to and must comply with all ongoing and periodic on-site inspections to ensure continued compliance. Member Bouvier seconded the motion, the Board roll call vote was unanimous at 3-0 in favor of the motion
