Honorable President Ossing and Councilors:



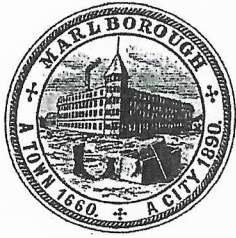

Honorable President Ossing and Councilors:


