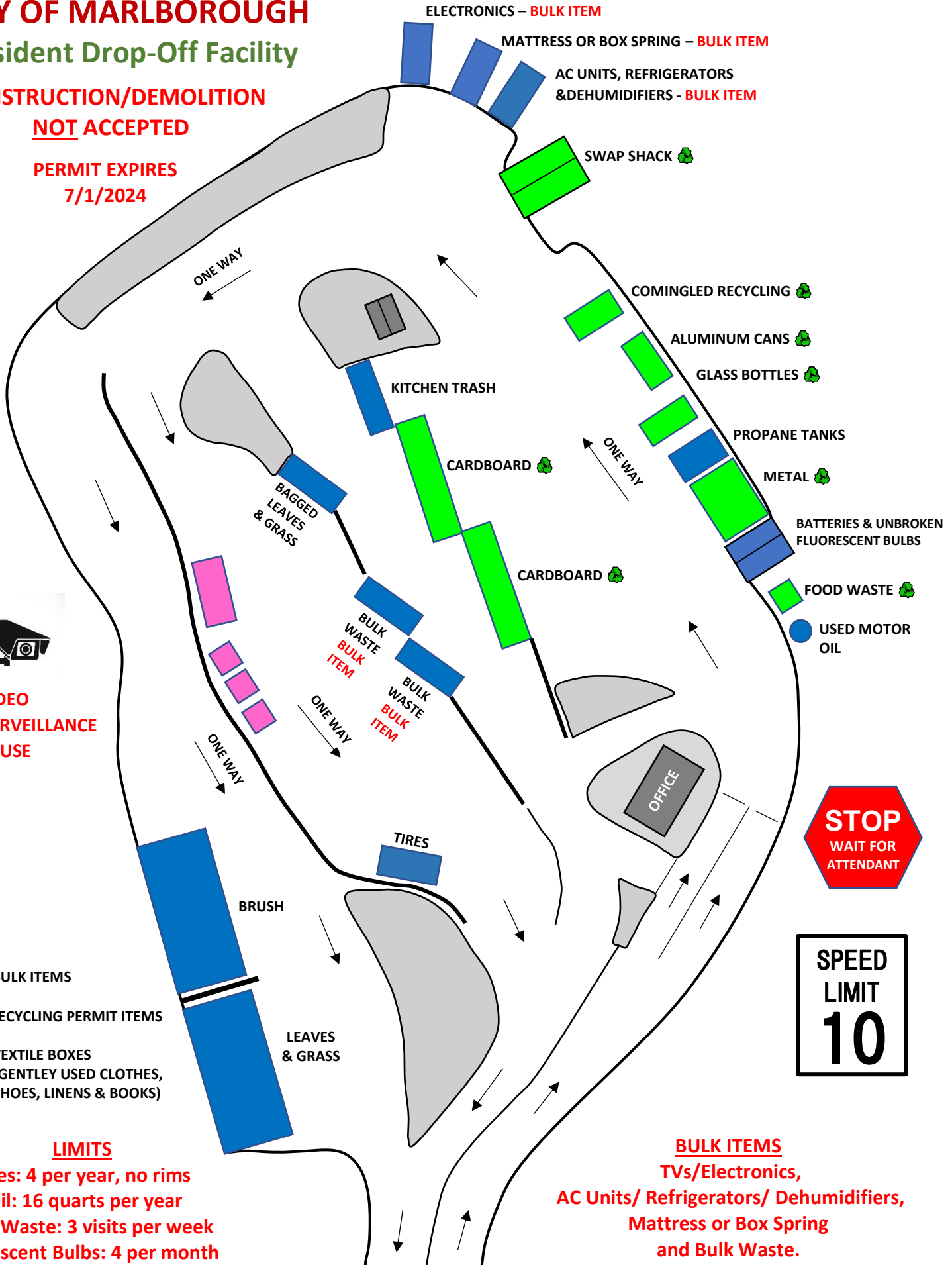

**Marlborough residents may dispose of the following items with a current Resident Drop-Off Facility Permit. Disposal is based on the number of items a permit holder has on their permit. Recycle items have no quantity restriction.**

PERMIT TYPE	FEE	INCLUDES
Tier One	\$50	6 bulk items; 50 bags of kitchen trash (30-gallon bag max. size, 1 mil max. thickness)
Tier Two	\$100	4 additional bulk items (10 bulk items total); total for permit upgrade \$150
Tier Three	\$100	4 additional bulk items (14 bulk items total); total for permit upgrade \$250
Tier Four	\$100	4 additional bulk items (18 bulk items total); total for permit upgrade \$350
Senior Citizen (65+)	No fee	6 bulk items; 50 kitchen trash bags; fees apply for tiers two-four at \$100/tier
Disabled American Veteran*	No fee	6 bulk items; 50 kitchen trash bags; fees apply for tiers two-four at \$100/tier
Recycling Only	No fee	Recycling of cardboard, paper, various plastics, aluminum, metal ( <b>metal motorized yard equipment</b> must be free of gasoline and oil), compost, swap shack

- ◆ **Number of Permits Per Household:** Limited to one tier permit and one recycling only permit per household.
- ◆ **Form of Payment:** Personal checks or money orders are the only form of payment currently accepted.
- ◆ **Required Documents for Permit Issuance:** Massachusetts Driver’s License and Vehicle Registration as proof of Marlborough residency. New residents, require a utility bill as proof of Marlborough residency. \*DAV – proof required.
- ◆ **Permits Issued:** Monday - Saturday from 8:00 a.m.- 4:45 p.m.
- ◆ **Permit Affixed Location:** All permits shall be affixed to and shall remain on the lower left windshield corner.
- ◆ **Permit Transfer/Reissue:** Allowed one time per year for replaced vehicle or windshield; no fee.

BULK ITEMS	BULK ITEMS USED	RESTRICTIONS
Mattress or box spring	1 bulk item each	Resident must handle these items without facility assistance
A/C, dehumidifier, refrigerator	1 bulk item each	Remove refrigerator doors; doors & plastic bins placed in bulk
Electronics – TV’s, computers, etc.	1 bulk item per load	One load = various electronics; no more than one TV/monitor
Bulk furniture, home décor, toys, etc.	1 bulk item per load	Max load Size 8’x5’x2’; heaped load not accepted
Kitchen Trash (over 50 bags)	1 bulk item=12 bags	One bag can be up to a 30-gallon max. size, 1 mil max. thickness
SPECIAL TYPES OF WASTE	LIMITS	RESTRICTIONS
Yard Waste	3 visits/week	Yard Waste must be plastic bag free. Brush/branches 8”x4’ max
Tires	4 per year	Metal wheels/rims must be removed; 20” tire size max
Motor Oil	16 quarts per year	Motor oil cannot be contaminated with any other liquids
Propane Tanks	3 per year	
Fluorescent Bulbs	4 per month	Only <b>unbroken</b> bulbs accepted
Batteries, thermostats, smoke alarms	No limit	<b>Single use batteries should be disposed of in kitchen trash</b>
Food Waste for Compost	No limit	

#### GENERAL FACILITY RULES

- Visitors must check in at the office prior to using the facility. Please remain in vehicle and an attendant will assist you.
- **Scavenging is not permitted** at any time while visiting the facility.
- **Residential construction and demolition materials and commercial waste are not accepted.**
- Residents are allowed four times per year, the use of a non-commercial vehicle for bulk loads.
- **Swap shack** closes daily at 4:00 p.m.
- We appreciate all visitor’s adherence to these rules and reserve the right to revoke permit privileges if these rules are not followed or if the visitor causes any serious disruption.
- **Please respect the cleanliness of this facility.**
