Applicants for a Firearm Identification Card (FID) are required to complete a Massachusetts Firearms Safety Course or Hunter A Safety Program approved by the Massachusetts State Police in accordance with Chap. 140 Sec. 131 P. Persons applying for a License to Carry Firearms must complete and approved Massachusetts LTC Basic handgun Safety Course. Out of State courses do not meet the criteria for Massachusetts Firearms Licensing. A safety course is not required for a restricted FID card (Chemical Propellant).

It is strongly recommended that you read the application completely prior to signing up and paying for a safety course or applying for a firearms license. Pay particular attention to questions 1 through 15 page 2 of the application, if there are any questions concerning your eligibility based on these questions, feel free to ask the licensing officers prior to applying. The application fee covers the cost of processing the application and is non-refundable if you are denied the license.
