CONSUMER NOTIFICATION**

The City of Marlborough is pleased to announce that **Public Power** has been selected as the supplier for its Community Choice Power Supply Program ("Program"). Public Power will provide electric power supply for all consumers participating in Marlborough's Program. This notice is intended to tell you about this Program for electric power supply. In accordance with state law, it also informs you of your rights and options if you choose not to participate in the Program.

**YOU WILL NOT NOTICE ANY CHANGE IN YOUR ELECTRICITY SERVICE.** You will see Public Power printed under the "Supply Services" section of your monthly bill. You will continue to receive one bill from National Grid. You will continue to send your payments to National Grid for processing. National Grid will continue to respond to emergencies, read meters and maintain the distribution and transmission lines. Reliability and quality of service will remain the same. Furthermore, you will continue to have all existing consumer rights and protections.

**PARTICIPATING CONSUMERS** will start benefiting from the aggregation rate beginning on the day of the month in May 2018 that their meter is read. This date varies by service area. Your meter reading date is shown on your bill.

**WATCH YOUR NATIONAL GRID BILL FOR FURTHER NOTIFICATION** of the Program.

- Your May 2018 bill will state that you are being switched to **Public Power (Marlborough Aggregation)**.
- Your June 2018 bill will show Marlborough's new supplier and aggregation rate under "Supply Services".

**IF YOU ARE A BASIC SERVICE CONSUMER WHO HAS BEEN MAILED A NOTIFICATION** you do not need to take any action to participate. You will automatically be enrolled. If you do not wish to participate, please follow the instructions specified.

**IF YOU WISH TO JOIN THIS PROGRAM** you may OPT-IN at [www.colonialpowergroup.com/marlborough/](http://www.colonialpowergroup.com/marlborough/) OR call Public Power at (800) 830-2944 and ask to be enrolled.

**IF YOU DO NOT WISH TO PARTICIPATE** you must OPT-OUT at [www.colonialpowergroup.com/marlborough/](http://www.colonialpowergroup.com/marlborough/), click the OPT-OUT button and follow the instructions specified OR call Public Power at (800) 830-2944.

**TO CHOOSE A GREENER PRODUCT WITH A HIGHER PERCENTAGE OF RENEWABLE ENERGY** you may call Public Power at (800) 830-2944 and ask to be enrolled in Marlborough's Optional Green Product. Marlborough's Optional Green Product provides 100% renewable energy, including 77% National Wind Renewable Energy Certificates (RECs). This product is being offered at \$0.10226 per kWh for 6 months (May 2018 to November 2018).
