Traffic Commission Minutes

The Regular Meeting of the Traffic Commission was held on Wednesday, August 29, 2018 at 10:00 am in Memorial Hall, 3rd Floor, City Hall. Members present: Chairman - Police Chief David Giorgi, DPW Commissioner John Ghiloni and City Clerk Lisa Thomas. Also present: City Engineer Tom DiPersio, Assistant City Engineer Tim Collins and Officer Andy Larose – MPD Traffic Services Unit. Minutes taken by Karen Lambert, MPD Records Clerk.

1- Minutes

The minutes of the Traffic Commission meeting of Wednesday, July 25, 2018.

MOTION was made, seconded, duly VOTED:

TO APPROVE - Accept and Place on File.

(Lisa Thomas abstaining as she was not present at last meeting.)

2 - New Business

2a) Traffic Issues at Intersection of Lincoln and Bond Street

A local resident of Bond Street came into the station to discuss traffic issues at this intersection. She spoke to Carrie Lizotte and was advised that her issues would be brought to the attention of the Traffic Commission. She said that the traffic has been getting worse and cars fly down the street. She also said that there was a stop sign that had not been replaced and that bushes needed to be cut back. Ms. Lizotte also forwarded the issue regarding the bushes to Code Enforcement.

Tim Collins advised that there has never been a stop sign at this intersection. He said that all signs that were supposed to be there are there now. He mentioned there is a new

curve in the road. It used to be a Y intersection and now it's a T intersection. Chief Giorgi advised that he also dove down there to look at the intersection and saw this.

MOTION was made, seconded, duly VOTED to ACCEPT and PLACE ON FILE. No further action required.

2b) Ash Street Concerns - Speeding & Sidewalks

Local resident, Michelle Chiasson, noted several concerns in her original email to the DPW. Chief Giorgi emailed her back on 8/14/18 and advised that her concerns on Ash Street would be added to the Traffic Commission Agenda for the 8/29/18 meeting. He also advised her that he asked the Traffic Unit to focus their enforcement efforts on Ash Street from that date until the meeting and to place the portable speed sign here so that they would be able to gather accurate information for the meeting.

In her email, she mentioned that Ash Street "acts as a racetrack for thru traffic". She said the speed limit is 25 mph, however, there is only one sign and it is "hanging by a thread". She said that it is hardly visible and was recently knocked over. She mentioned cars going 50mph and major accidents and being unable to walk dogs and children in strollers on the road. She also said there was a Slow Children sign that was hidden behind trees. She gave several suggestions as to what she would like to see done here.

Officer Larose advised that they first put the speed sign closer to the Rail Trail as there had also been complaints here. Ms. Chiasson asked for it to be moved closer to her home where it has been for the past 7 days. The results show that overall, 85% of vehicles were compliant with the speed limit. The maximum speed came up at 43mph. Officer Larose did however agree that the volume is heavy and when you are sitting out there it does look like people are flying down the road, however, truly they are not speeding. They have had the speed sign out for 7 days in one direction and now it has been 3 days in the other direction.

With regard to the sidewalk request, Commissioner Ghiloni advised that there are currently no plans for sidewalks here. Tim Collins advised that there are actually 3 speed limit signs here, two of which are on the entering streets. He did also see that the sign near Ms. Chaisson's house had been knocked over and is bent. He advised that the City would move it to the telephone pole which they usually do not do. He also advised that the trees have now been trimmed back.

MOTION was made, seconded, duly VOTED to ACCEPT and PLACE ON FILE. Chief Giorgi or Officer Larose will get back to Ms. Chaisson to advise as to the discussion.

2c) Request for sound activated crosswalk signal at corner of Lincoln St. & Bolton St.

This request came from Jody Hoge on behalf of her father, who is blind, and walks this route regularly. Tim Collins advised that this crosswalk already has a push button with a countdown to cross. The push button at this intersection can be replaced with an audible signal.

MOTION was made, seconded, duly VOTED to REFER to Chief Giorgi to advise Ms. Hoge that the audible signal will be installed. REMOVE FROM AGENDA.

3-Old Business

3a) Request for stop signs on Weed St. at Florence St.

<u>Update</u>: Commissioner Ghiloni advised that this item is "almost there" but still in process.

MOTION was made, seconded, duly VOTED to TABLE.

Chief Giorgi asked if there were any other issues for discussion.

- 1) Lisa Thomas advised that the recent regulation for No Stopping, Standing or Parking on Elm Street will be advertised on 9/15. She tries to get the best rates and sometimes needs to spread them out.
- 2) Chief Giorgi asked if we could put a stop sign on the island at the intersection of Hildreth St., Maple St. & Main St. All agreed that this could be helpful. Tim Collins will add the second sign, though he noted that it may very possibly get hit.
- 3) The Traffic Commission received a request for a handicapped sign on Prospect Street as a resident has difficulty crossing the street. Tim Collins advised that he sent the Warning Sign Permit Application for completion.

That there being no further business of the Traffic Commission held on this date, the meeting adjourned at 10:15 am.

Good Morning

I was passed along your email address to voice my concern about the intersection of Northborough Rd W and RT 20 directly in front of Our Future Learning Center. My son attends this school and I am entering and exiting two times per day, majority during the rush hour time. Since the new turning lane and bike lane opened I have seen may near collisions as well as witnessed the aftermath of two accidents already. Heading east on 20, turning into the entrance of OFLC is treacherous now. One lane will allow the passing of a car but those traveling up the turning lane heading towards to lights are going too fast and can't see the other passing traffic. They are going over a hill leading up to that road and intersection.

I would like to request someone research this spot during rush hour to view the traffic patterns, preferably not a police cruiser (so not to impact drivers normal actions). I think that opening a turning lane *after that entrance* make sense but certainly not before.

I appreciate your consideration and our concern about this matter. I would hate for another accident to happen in this spot, especially with so many children in that vicinity each day.

How would you suggest proceeding and getting the right people involved to fix this traffic issue before someone is killed? I think this is obviously more than just enforcement and an issue with the design. Two cars totaled in as many months and it's only a matter of time that people are not walking away in one piece.

We're writing to express my concern about the changes to lane configurations just prior to the intersection of 20 and Boundary Rd.

As parents whose child attends Our Future Learning Center, we were at first delighted that there was additional construction work to improve the intersection. Now that the work is completed, however, we find that it had created many more problems than it seems to solve. Cars wanting to head westbound and turn right onto Boundary Rd from 20 come over the crest of the hill early before the turning lane appears. They often are doing 45MPH or more. Exiting OFLC it can be dangerous because these cars have poor visiblity as they crest the hill. Entering OFLC (especially traveling eastbound on 20) there's an issue of cars in this lane failing to see turning vehicles due to traffic waiting to proceed through the signal.

One solution would be to mark the intersection with indicators not to block the entry way. This would help more drivers be aware of entering and exiting parents. Additional signage would also help. Another significant help would be to have a devoted turn lane for cars entering the daycare Eastbound where there is already an existing painted median.

We appreciate the hard work the city has done to improve the intersection, but it appears at least for our daily commute to OFLC that it has decreased safe access and encouraged drivers to speed past the entrance without thought to its use or child safety.

I'm writing to you to express my concern around the traffic situation at the entrance/exit to Our Future Learning Center daycare in Marlborough, and to ask that you address the dangerous situation there.

Witnessing one major accident at that spot and becoming aware of another major one made me very concern about the times when I drop off or pick up my daughter from the school. We live in Shrewsbury and every time I turn left to go into the center I triple and quadruple check that there is no car rushing up on the opposite lane (on the side of the road), knowing that if a hit happens my son who is with me in the car would definitely be severely hurt.

I understand that this risky situation started once the construction in that spot were completed, however I'm sure that there are fairly easy ways to prevent cars from rushing up on the other direction where there is no real lane, and where there is no visibility, preventing the next major accident.

I would really appreciate it if you could take the time and provide the attention to address this very concerning issue.

Hello,

The City of Marlborough is going to get someone killed if they don't fix that lane in front of Our Future Learning Center sooner rather than later. That is an incredibly dangerous street where you have a lane beginning right before the entrance of that daycare. I recently saw that an accident occurred there, and I often see situations where drivers are literally at risk of getting sideswiped because drivers are flying down the right-turn lane.

A simple solution: have the line for the right-turn lane on the street start several yards AFTER the entrance. Also it would be helpful to also put a sign up before the entrance that children are nearby, etc. Anything to slow down drivers.

It's terrifying and I hope this gets prioritized.

Chapter 586. Vehicles and Traffic

Article IX. Handicapped Parking

§ 586-73. Sticker application; fee; display. ON STREET PARKING PERMIT

- A. Applications for window stickers issued hereunder shall be made upon blank forms prepared and made available by the Chief of Police and shall state:
 - (1) The name and address and telephone number of the applicant.
 - (2) Nature of the applicant's handicapped condition.
 - (3) Whether the applicant has obtained a distinctive number plate issued by the Massachusetts Registrar of Motor Vehicles pursuant to MGL c. 90, § 2, and if so, the number of such plate.
 - (4) Certification by a physician duly licensed by the Commonwealth of Massachusetts that the applicant is a physically handicapped person.
 - (5) Make, model, year, color and license plate number of the motor vehicle which will be utilized in transporting the applicant, unless the applicant has obtained a distinctive number plate as hereinabove described in Subsection A(3).
- B. An application bereunder shall be accompanied by an application fee of \$1.
- C. The window sticker, which shall contain the City Seal, as described in § 1-5 of the City Code, and the International Sign for Handicappers, shall be displayed on the lower-left side of the rear window of the vehicle licensed.
- A. APPLICATIONS FOR ON STREET HANDICAP PARKING SPACES MUST BE FILLED OUT COMPLETELY AND EUBMITTED TO THE CHIEF OF POLICE AND VOTED ON BY THE MARLBOROUGH TRAPPIC COMMISSION.
- B. APPROVED PERMITS MUST BE RE. APPLED FOR EVERY JANUARY

A regulation to amend the Rules and Regulations of the Traffic Commission of the City of Marlborough Chapter 586, as amended, thereof entitled <u>VEHICLES AND TRAFFIC</u>, Article IX, Handicapped Parking, Section 73: "Sticker Application; fee; display".

BE IT ENACTED BY THE TRAFFIC COMMISSION OF THE CITY OF MARLBOROUGH AS FOLLOWS:

Chapter 586 Section 73 Article IX entitled "Sticker application; fee; display" of the Rules and Regulations of the Traffic Commission is hereby **DELETED** in its entirety, and **ADDING** in place thereof a new Section 73 entitled "On Street Parking Permit", as follows:

Chapter 586, Section 73, On Street Parking Permit

A: Applications for on street handicap parking spaces must be filled out completely and submitted to the Chief of Police and voted on by the Marlborough Traffic Commission.

B: Approved permits must be reapplied for every January to ensure applicant's continued residency.


