### **Traffic Commission Minutes**

The Regular Meeting of the Traffic Commission was held on Wednesday, January 29, 2020 at 10:00 am in Memorial Hall, 3<sup>rd</sup> Floor, City Hall. Members present: Chairman - Police Chief David Giorgi, DPW Commissioner John Ghiloni, Fire Chief Kevin Breen and City Clerk Steve Kerrigan. Also present: Assistant City Engineer Tim Collins, Sgt. Zac Attaway and Officer Andy Larose from the MPD Traffic Services Unit and City Councilor Christian Dumais. Minutes taken by Karen Lambert, MPD Records Clerk.

## 1- Minutes

The minutes of the Traffic Commission meeting of Wednesday, November 27, 2019.

MOTION was made, seconded, duly VOTED:

TO APPROVE - All in Favor - Accept and Place on File.

## 2 - New Business - (2a & 2b discussed together)

## 2a) Poor Streetlight Conditions - West Main St./Winthrop St.

Councilor Irish submitted this issue on behalf of a concerned resident after the recent pedestrian accident at this location. He referred to it as "the subpar street lighting situation on West Main St./Winthrop St."

## 2b) Request for Crosswalk Warning Signage – West Main St. @ Winthrop.

Sgt. Attaway submitted this request for the same intersection. In addition to the recent pedestrian accident here, he also noted that "the crosswalk is commonly used for foot traffic going to and from Short Funeral Home and it leads to a school on Orchard St."

Officer Larose was on scene the night of the pedestrian accident. He is a member of the CEMLAC Reconstruction Team and is the lead investigator for this accident. As background, he explained that the female pedestrian was crossing from the South side to the North side at Short Funeral Home with 2 dogs when she was hit in the crosswalk. Both dogs were killed. The pedestrian was seriously injured but will be OK.

The investigation is ongoing, however, he pulled up photos of the intersection along with video of the roadway showing both dry and wet conditions from different views. In the daylight when dry, the visibility was pretty good even though the crosswalk is faded. The video showing wet conditions was taken the same night as the accident. He noted that the rain and the glare from the lights makes the crosswalk almost invisible. He doesn't think it is due to the street lighting. Even in the daylight it can be difficult to see the crosswalk. The accident occurred at 8:26 pm. It had been raining during the day and was misty at the time of the accident. The speed limit here is 30 mph (not posted) and there are no advance warning signs for the crosswalk. He explained that a vehicle travels 44 feet per second at 30mph and would need 114 feet to see, react and stop. Chief Giorgi asked if you could see the crosswalk with better paint? Or if not, because of the grade of the road? Tim Collins said that the safe thing is to not enter the crosswalk until the road is clear. The pedestrian also has some responsibility. All agreed that the crosswalk should be repainted. Another issue is that this particular crosswalk is almost a midblock crosswalk and a driver doesn't expect to stop here.

Officer Larose said that he has been monitoring the area since the accident and that this is a very busy crosswalk. He said that he didn't realize how many people actually cross here. It would also be helpful if Short Funeral Home had a sign that they could put out during services that would designate, "Yield to Pedestrians".

MOTION was made, seconded, duly VOTED to REFER to ENGINEERING to paint the crosswalk and install advance warning signs and to REFER to Sgt. Attaway to reach out to Short Funeral Home on the sign. Also, Chief Giorgi will talk to Councilor Irish and advise him of the discussion.

## **3-Old Business**

## 3a) Parking Issues on John Street around the playground area.

Chief Giorgi prepared the amended regulation for the "Time Limit parking" on John Street (i.e. No Parking from Dawn to Dusk) near the playground and presented it for a vote.

MOTION was made, seconded, duly VOTED to APPROVE the regulation as drafted.

## 3c) Hillside School - Dangers on Robin Hill Street.

<u>Update</u>: Tim Collins advised that there was nothing on the site plan about putting in a crosswalk. It was discussed that the Traffic Commission can create the safety zone for children to cross, however, the regulation should be contingent upon the school putting in the crosswalk. Chief Giorgi advised that he can talk to the school or Priscilla regarding the site plan.

Tim Collins said that the members of Site Plan brought up these traffic enhancements and now the finance people want to make sure the plan is approved. The plan has been "conceptually" approved by Site Plan. All agreed the plan was "conceptually" OK.

That there being no further business of the Traffic Commission held on this date, the meeting adjourned at 10:31 am.

I am following up on the below email, which I sent Monday. Is there any update?

Coming home today, there was a van exiting Lakeside Avenue, which I didn't see until the last minute due to the cars parked alongside Lakeside Avenue. ### Dear Councilman Tunnera:

I am a unit owner at 45 Lakeside Avenue and now that The Fix has opened I am finding people parking on Lakeside Avenue has become a traffic hazard that didn't exist prior.

If you are entering Lakeside Avenue from Route 20 east, due to the cars parked on the side of the road, you are unable to see if a car is exiting Lakeside Avenue onto Route 20. The other issue is that the parked cars only allow for one car at a time to either exit or enter, as the roadway is not wide enough for two cars to travel when cars are parked on the side of the road. Entering Lakeside Avenue from Route 20 west is even more dangerous due to the hairpin turn you take into a blocked view area.

The weather has been rainy & snowy these past couple of weeks & the tire tracks left in the mud onto the grass is a problem; whether this will be a long-term problem once the mud has dried, I'm unsure. In other words, will the "well" created by tires be permanent or will it fix itself?.

I'm not sure I understand why parking is allowed on this road considering it impedes the safety of the residents entering & existing the complex; it may also be an issue for those who are parking on the road.

I'm not 100% sure that this parking issue is due to The Fix. I say this because on several occasions I've arrived home & the parking lot @ The Fix is practically empty, yet cars are parked on Lakeside Avenue. Today (2/10/2020), I arrived home @ 3:45 p.m. The Fix parking lot had about 8 cars in it yet there were just as many parked on Lakeside Avenue.



### THE PROBLEM:

Dangerous driving and pedestrian walking conditions caused by a sudden big increase in cars parked by the berm on Lakeside Avenue, making this street essentially into a single narrow lane where the cars are parked with terrible visibility. The street is in poor repair, but two cars could see and pass with safety at low speed.

In addition to danger to person and property, the berm is being torn up by the wheels. This is public property but the visual degradation is less important than the potential accidents waiting to happen.

#### **DESIRED ACTION:**

An immediate sign and enforcement of no parking on that side of the street. This should be done before the winter weather sets in.

It seems that the main problem is that The Fix is using this area for their valet parking. That is a rumor, but I wonder if they have permission for using this area or if they need it.

IF the problem is due to The Fix using this area for valet parking, have them cease. Park elsewhere on a legal street area or an agreed on private property. There are many cars, as in 10 to 20, and I believe they are also using the Real Estate parking lot. They may have permission for that though.

### **ACTION TAKEN SO FAR:**

Several of the people I know at our condos have called to complain, with no effect. The police say they only enforce the law. Well, what is the law or regulation for that area?


I have called my councillor (Robert Tunnera) who might have spoken to someone. I also spoke with someone at the DPW, who said she'd pass on my concerns but to address my councillor.

#### THIS CAN'T REALLY WAIT!!!

It could be that there is already a no-parking ordinance but the sign has disappeared.

I don't think this can wait until the next Traffic Commission meeting for these reasons:

- Dangerous because parked cars block view of both pedestrians and on-coming cars.
- Especially bad at night.



- Lack of sidewalks makes Lakeside Avenue the only way to get from West Main by foot toward 495 and beyond. There was supposed to be a sidewalk, but it was never built.
- This street is used by a lot of dog walkers and people who walk to work at the Apex Center and the Hannaford Plaza, etc. It is especially busy in the better weather.
- With bad weather, the restriction of space is an accident waiting to happen. One skid would
  do it as there is no maneuvering room.
- There is an uptick in truck traffic because of Amazon and UPS etc. And there are sometimes service vehicles and moving vans. So, any restricted access is, I think, unacceptable.
- I am not sure that the restriction caused by cars and trucks parked by the berm won't impede emergency vehicles and larger trucks.
- Business filing for The Fix -- does it include valet parking? If so, where was approved for their actual parking? If not -- suggest telling them to stop or find a private parking space (for example, the defunct gas station comes to mind. Or an arrangement with some local businesses after hours. Not really satisfactory -- thinking of summer and increased traffic.

#### INFORMATION THAT HAS BEARING ON THIS PROBLEM:

- Does anyone check the rated occupancy? I haven't been there, but the number of cars far exceeds the Allora. That might not mean anything though.
- About the street it is a two-way street? No center line. The "berm" (don't ask me) is a
  poorly constructed dumped earth and the parking is wrecking the edges. People use this for
  walking dogs and people.
- · Parking is not allowed on ht side away from the lake, and that is obeyed.
- I believe we had this problem before the old berm was destroyed and there was no parking on either side. A new sign never went up, but until the Fix, no one has been parking there.
- There was supposed to be a sidewalk that was never constructed in the boondoggle, and so people who walk are forced to share with vehicles. The increase in traffic is making this dangerous, especially at night with reduced visibility.

Hi Councilor Dumais,

Thank you very much for your reply and for taking the time to address each of my ideas below. Since I first wrote you regarding this situation, I have received some additional insight on the Commercial Vehicle Exclusion from Traffic Engineering via the Marlborough SeeClick Fix website.

I asked why commercial trucks over 2.5 tons are banned from Farm and Framingham roads, but not Brigham Street. Please see the discussion below. Please note that "X" is my SeeClickFix user name.

Marlborough Traffic Engineering and MassDOT are focused on two "requirements":

- 1. Commercial vehicle volume *should* (note that the word "must" was not used) be between 5% and 8% of total traffic volume.
- 2. The identified alternative route through Marlborough is a "bit circuitous".

My responses to the these two issues are:

1. Twelve years ago truck volume was only 1% below the requirement for an exclusion. Marlborough and MetroWest traffic have increased significantly since then. Can the Engineering Division revisit this and get a current truck traffic volume on Brigham Street?

2. If large commercial vehicles are such a low percentage of total traffic volume, then the alternative route would slightly inconvenience only a small percentage of the drivers.

More importantly, neither Marlborough Traffic Engineering nor MassDOT have considered the unique layout of Brigham Street and the close proximity of the houses to the street. There are several choke points along Brigham Street where it is impossible for tractor-trailers or large box trucks to pass oncoming traffic without one side having to come to a complete stop and move to the extreme edge of the road. Further exacerbating the situation is the fact there are no sidewalks along Brigham Street and many of us in the neighborhood use the road surface for walking, jogging and cycling.

When one compares Brigham Street to Farm Road and considers the width of the two road surfaces, the presence/absence of sidewalks, and the proximity of houses to each road, it makes no sense that Brigham Street does not have Commercial Vehicle Exclusion. Tractor-trailers and large box trucks simply do not belong on Brigham Street.

Thanks again for your time, consideration and representation on these issues. I hope we can make some progress.

### CLOSED Engineering - Traffic (Verified Official)

The intent of the Commercial Vehicle Exclusion is not to have Framingham Road and Farm Road used a "cut through" for truck traffic to and from Route 85 and Route 20.

Commercial Truck Exclusions must be approved by the Massachusetts Department of Transportation (MassDOT). An original request for a Commercial Vehicle Exclusion of Framingham Road and Farm Road, in October of 1978 was denied. On August 20, 1980 a second request (per Marlborough City Council Order 20960) was submitted to MassDOT. In a letter from Floyd Russel - Police Chief and Paul Sharon - DPW Commissioner to MassDOT, it stated in part that "Farm Road is a narrow, winding, thickly settled road which joins Route 85 and Route 20. An elementary school is located on this road. The heavy traffic is detrimental to the safety and also the peacefulness of this residential area." MassDOT approved the Commercial Truck Exclusion on February 10, 1981. The 1981 Alternate Route for Commercial Vehicles would be "by way of Maple Street, East Main Street and Boston Post Road". The current Alternate Route would be by way of Maple Street, South Bolton Street, Granger Boulevard, East Main Street and Boston Post Road - East.

Thank you for your quick response. My follow up question is: Why is there not a Commercial Vehicle Exclusion on Brigham Street?

With the exception of the elementary school, the same exact situation exists on Brigham Street: Brigham Street is a narrow, winding, thickly settled road which joins Route 85 and points west of downtown Marlborough. The heavy traffic is detrimental to the safety and also the peacefulness of this residential area.

Farm Road has two full-width lanes and sidewalks. Brigham Street is much narrower without sidewalks. If commercial trucks are excluded from Farm Road, it makes sense that they should be excluded from Brigham Street as well.

Large commercial trucks rumble down Brigham Street on a daily basis. Can a request be made to MassDOT for a Commercial Vehicle Exclusion on Brigham Street please?

#### **CLOSED** Engineering - Traffic (Verified Official)

In order for MassDOT to grant a Commercial Vehicle Truck Exclusion the commercial vehicle volume for the road should have a range between 5% - 8% and the Alternate Route would have to be approved by MassDOT. In 2002, at the request of the Marlborough Traffic Commission, the DPW contacted MassDOT about having a Commercial Truck Exclusion on Brigham Street. The commercial vehicle percentage of traffic volume was around 2%, and the alternate routes either was through Southborough, which required their permission (that they would not give) or was over Maple Street, South Street, West Main Street, Lakeside Avenue, Williams Street, Clover Hill Street to Brigham Street, which is a bit circuitous. MassDOT stated that Brigham Street was not a good candidate for a Commercial Vehicle Exclusion.

In 2007, the Marlborough Traffic Commission had the DPW - Engineering Division research the possibility of Brigham Street meeting the warrants for requesting a Commercial Vehicle Exclusion. The truck volume was below the minimum required (at 4%) and the Alternate Route could not be shortened, so that was still unacceptable.

# On Nov 8, 2019, at 10:45 AM, Michael Kerick wrote:

Hello Councilor Dumais,

Thank you for your letter. I would like to be added to your Ward 3 mailing list.

I do have an issue that I hope you as Ward 3 Councilor can help to resolve. Traffic along Brigham Street is a big problem for us residents who live in the neighborhood. Brigham Street is heavily used as a commuter connector between Maple Street and points West of downtown Marlborough. Every single day I witness speeding, tailgating and reckless driving. The street is also regularly used as a shortcut by large trucks.

Brigham Street was originally laid out back in the 1600s. As such it is a winding road that is very narrow in some spots. Also, there are no sidewalks along the street, so residents must walk on the road surface. Because of these factors, the reckless driving and large trucks create a dangerous situation for both motorists and pedestrians.

I have voiced my concerns to the Police and Traffic Departments. The police do conduct a speed monitoring and enforcement activity twice a year on Brigham Street. While I do appreciate their efforts, it is not enough. Something more needs to be done proactively before there is a serious accident.

#### Some ideas:

 Close Brigham Street permanently near where the power lines cross just east of Jericho Hill. Install a remote controlled gate so that emergency vehicles, school buses and other authorized vehicles can pass through. This will completely eliminate the problem.

A gate being installed was brought up in a new development area for a road that was only for emergency vehicles and that was not approved due to a liability if the gate malfunction. This malfunction could / would cause more of a delay when time is off the essence.

 Install speed humps at various key locations along Brigham Street. Speed humps are used very effectively in other communities.

You are correct speed bumps can be effective however from going to traffic commission meetings there is a lot of hesitation with speed bumps. Once one neighborhood gets them installed then everyone neighborhood will want

them. I know a standard based on need is being looking at by the DPW Commissioner. Also, in other communities speed bumps are installed and theyn often times removed because they neighbors who deal with them day in and day out get annoyed with them and then wanting them removed.

 Install permanent electronic flashing speed monitoring signs at key locations. These signs are used effectively on Farm Road, Bigelow Street and West Hill Road in Marlborough.

I will being this up during the traffic commission meeting.

4. Ban large trucks from Brigham Street (except for those making local deliveries). Commercial trucks over 2.5 tons are prohibited from using Farm and Framingham Roads, but not from Brigham Street. Farm and Framingham Roads have two full width lanes and sidewalks, while Brigham Street is much narrower and has no sidewalks. If large trucks are prohibited from using Farm and Framingham Roads, they should also be prohibited from using Brigham Street.

> I will look into this as well with the traffic commission as to what are the qualifications to exclude these vehicles.

Again, I sincerely hope we can do something proactively here, and not wait to react only after something bad has happened. It's only a matter of time.

I am writing to submit to you a request to add a "No Right on Red" sign at the intersection of Farm Road, Boston Post Road and Mustang Ave. (see attachment A for a map showing this intersection)

There is already a red light at this intersection as well as a crosswalk. I feel that this should be enough to prevent people from driving through the light as if it were a right hand turn. However, in the past two days, I have had two different drivers honking angrily at me for not going through this light.


This morning on a Facebook group for residents of the city of Marlborough, I posted about my frustration with this intersection. In short order, it has become obvious that the legality involved in whether or not this intersection is a legal turn is ambiguous. I have attached the transcript of that post (Attachment B) so you can see that residents are, in many ways, confused. Is this a right on red situation? Do I stop at this light and wait for it to turn green? There are people who are passionately debating which interpretation they are choosing. This becomes a problem when it comes to safety.


I do not personally need a sign there to tell me that this is not a legal right hand turn but it appears as many people do. In the interest of public safety (and lets be honest, some people need to be protected from themselves,) I feel that we really need a sign there to prevent traffic accidents. This intersection is merely blocks away from where a UPS driver was hit and killed last year. Anyone who drives Boston Post Road on a daily basis can attest to how dangerous the road is. Not to mention, anyone who lives on Farm Road (as I do,) has a firsthand knowledge of how lead-footed people drive coming off of Farm Road and onto Boston Post Road.






